The Cyprus Musculoskeletal and Sports Trauma Research Centre of European University Cyprus, and the Laboratory of Neuromuscular and Cardiovascular Study of Motion of University of West Attica, Greece agree to promote collaboration between the two centers in joint research activities;

#### Article 1

Both parties agree with the following forms of collaboration within their common areas of interest:

- a. to explore collaboration in research;
- b. to invite each other to participate in seminars and conferences organized by the respective institutions;
- c. to explore organization of joint conferences and workshops;
- d. to support mutual visits by faculty members and researchers;
- e. to explore submission of joint proposals;





- f. to explore submission of joint publications;
- g. to exchange scientific information in the form of publications, instruction material and other results of teaching and research.

### Article 2

The terms of cooperation for each specific activity implemented under this cooperation agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that agreement.

# Article 3

Both parties agree that financial aspects shall be regulated on a case-by-case basis for each concrete action or project. As both partners are aware of existing restrictions in their respective budgets, they will, as a rule, not enter into financial actions without the consent of the other party.

## Article 4

Each party shall designate a liaison officer to develop and coordinate the specific activities agreed upon.

## Article 5

This cooperation agreement shall become effective for an initial period of three (3) years from the date when the representatives of both universities sign the agreement. After the initial period it may be renewed annually by written agreement of both parties.

## Article 6

The agreement is subject to review and may be terminated by either party by written six (6) month notice. The specific activities mentioned in article 2 envisaged in this cooperation, will be concluded separately.
